However, Semi-Conductor Laboratory (SCL), an autonomous society under Ministry of Electronics & Information Technology, prior to 9th February 2022, was under the administrative control of Department of Space and is following the provision of exemption of reservation on scientific posts as per the instruction of Department of Personnel and Training (Earlier Department of Personnel and A.R) vide O.M. No. 9/2/73-Estt. (SCT) Dated 23rd June 1975 and O.M. No. 36012/27/94-Estt (SCT) dated 13th May 1994.
