- (a) the details of irrigated and unirrigated cultivable land in the country, State-wise;
- (b) the action plan formulated by Government to increase the area of unirrigated cultivable land in the country;
- (c) whether Government has any action plan to increase the area of irrigated and unirrigated cultivable land in Uttar Pradesh including the districts of Firozabad, Agra, Etah, Kasganj and Mainpuri; and
- (d) if so, the details thereof?

# STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF RAJYA SABHA STARRED QUESTION NO 194 REGARDING "IRRIGATED AND UNIRRIGATED LAND IN THE COUNTRY" DUE FOR REPLY ON 23.12.2022.

- (a): As per the latest available Land Use Statistics, Net Area Sown in the country is 1,39,351 thousand hectare out of which 71,554 thousand hectare area is irrigated. The details of State/UT-wise Net Area Sown, Net Irrigated Area and Net Unirrigated Area in the country are given at **Annexure-I.**
- (b) to (d): Government of India is implementing the following programmes/schemes for increasing the area under irrigation in the country.
- 1. Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) is being implemented from the year 2015-16 with an aim to enhance physical access of water on farm and expand cultivable area under assured irrigation and introduce sustainable water conservation practices. The components of PMKSY are as under:
- i) Accelerated Irrigation Benefit Programme (AIBP): Major and Medium Irrigation projects including National projects are being implemented by the Department of Water Resources River Development & Ganga Rejuvenation (DoWR, RD&GR). Under AIBP during 2016-17, ninetynine (including 4 projects in Uttar Pradesh) on-going Major/Medium irrigation projects (7 phases), in the country having balance estimated cost of Rs.77,595 cr. (Central Assistance-Rs.31342.50 crore and State Share-Rs.46253 crore) were prioritised in consultation with States for completion in phases. Out of these projects, AIBP works of 50 prioritized projects have been reported to be completed. During 2016-17 to 2021-2022, total Central Assistance (CA) and State Share (loan through NABARD) of Rs.13,754 crore and Rs.28,423 crore respectively have been released for these projects. With this an additional irrigation potential of 24.35 lakh hectare has been created in the country during 2016-17 to 2021-2022 out of which 7.63 lakh hectares is in Uttar Pradesh.
- ii) Har Khet Ko Pani (HKKP) is being implemented by the Department of Water Resources River Development & Ganga Rejuvenation (DoWR, RD&GR). HKKP consists of four subcomponents, being Command Area Development & Water Management (CAD&WM), Surface Minor Irrigation (SMI), Repair, Renovation and Restoration (RRR) of Water Bodies, and Ground Water (GW) Development component. CADWM works got restricted to only 99 prioritized AIBP projects in 18 States from 2016-17 onwards. Out of 99 prioritized projects, 88 (includes Narmada Canal Project of Rajasthan for non-structural intervention) projects in balance

Culturable Command Area of 45.08 lakh hectares were included under CADWM programme for the total estimated cost of Rs 18,736 crore with targeted Central Assistance of Rs 8235 crore. From financial year 2016-17 to 2021-22, the Central Assistance amounting to Rs. 2855.63 Crore has been released to the projects and States have reported expenditure of Rs 5620 crore with physical progress in Culturable Command Area of 16.41 lakh hectares. Recently, Government has approved continuation of the scheme till 2026.

As far as the State of Uttar Pradesh is concerned, two projects namely, Arjunsahayak and Saryu Nahar have been included under the CADWM programme for balance Culturable Command Area of 5.24 lakh hectare at a total cost of Rs 1861.67 crore with Central Assistance of Rs 914.93 crore. The Central Assistance amounting to Rs 156 crore has been released to the aforementioned two projects from FY 2016-17 to 2021-22.

Management Division of Department of Land Resources (DoLR) for development of rainfed/degraded lands in the country. The activities undertaken, *inter alia*, include ridge area treatment, drainage line treatment, soil and moisture conservation, rainwater harvesting, nursery raising, pasture development, livelihoods for asset-less persons etc. Under WDC 1.0, through the implementation of 6382 watershed projects funded by DoLR. As on 20.12.2022, out of the 6382 sanctioned projects, 6372 projects in 27 States and UTs of J&K and Ladakh have been reported to be closed /completed, including 249 projects of Uttar Pradesh. Between 2014-15 and 2021-22, 7.65 lakh water harvesting structures have been created / rejuvenated, 16.41 lakh ha additional area has been brought under protective irrigation and 36.34 lakh farmers benefited. In addition to this, about 1.63 lakh ha area has been brought under plantation (Afforestation / Horticulture etc.), 3.36 lakh ha of culturable wastelands has been treated and 388.66 lakh mandays have been generated from 2018-19 lo 2021-22.

Government of India approved continuation of programme as WDC-PMKSY 2.0 for the period 2021-22 to 2025-26 with a physical target of 49.5 lakh ha and financial outlay of Rs. 8,134 crore, as the Central share. DoLR has till date sanctioned 1110 projects to States/UTs (including 53 projects in Uttar Pradesh) and Central share of Rs. 1537.41 crore has been released to States /UTs, including Rs.21.78 crore to Uttar Pradesh. The district-wise details of number of projects (under WDC 1.0 and WDC 2.0) sanctioned in Uttar Pradesh state is given at **Annexure-II** 

2. Department of Agriculture & Farmers Welfare is implementing Per Drop More Crop (PDMC) Scheme which focuses on enhancing water use efficiency at farm level through Micro

Irrigation namely Drip and Sprinkler Irrigation systems. Under the PDMC 70.04 lakh hectare area is covered under Micro Irrigation. The district-wise area covered under micro irrigation in Uttar Pradesh State including Firozabad, Agra, Etah, Kasganj and Mainpuri districts from 2015-16 to 2021-2022 is given at **Annexure-III.** 

3. Under MNREGA, there are 265 works permissible out of which 182 works are related to Natural Resource Management (NRM) and out of the 182 NRM works, 85 works are water related. These works directly or indirectly support water conservation, ground water recharge, climate change and carbon sequestration. A total of 6409852 water bodies such as farm ponds, dug wells, check dams and community ponds (water harvesting & Fishery) have been created since inception under the Scheme. The details of water bodies created since inception are at **Annexure IV.** 

As part of Azadi ka Amrit Mahotsav, the Mission Amrit Sarovar has been launched on 24th April 2022 with an objective to harvest and conserve water for future generation. Under the Mission every district of the country has been targeted to construct or rejuvenate at least 75 Amrit Sarovars. Under Amrit Sarovar Mission, the details of works carried out in the said districts of Uttar Pradesh are as below.
