MSP OF AGRICULTURAL PRODUCE

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) the details of Minimum Support Price (MSP) of various agricultural produce in 2017, crop-wise;
- (b) the details of MSP of various agricultural produce as in 2022, crop-wise;
- (c) the details of cost of production per quintal as in 2017 and in 2022, crop-wise along with the facts considered for determining the cost, item-wise; and
- (d) the details of percentage of weightage of facts for determining the cost of production as in 2017 and 2022?

(a) to (d): The details of Minimum Support Price (MSP) and Cost of Production of mandated agricultural crops for 2017 and 2022 are given at **Annexure**.

While recommending MSP, Commission for Agricultural Costs & Prices (CACP) considers important factors like overall demand-supply conditions, cost of production, domestic and international prices, inter-crop price parity, terms of trade between agricultural and non-agricultural sectors, the likely effect on the rest of the economy, besides ensuring rational utilization of land, water and other production resources and a minimum of 50 percent as the margin over all India weighted average cost of production, which has been in operation since, 2018-19. The Cost of production, being an important factor in the determination of MSP, CACP projects cost for current year on the basis of actual paid out costs such as those incurred on account of hired human labour, bullock labour/machine labour, rent paid for leased in land, expenses incurred in cash and kind on the use of material inputs like seeds, fertilizers, manures, irrigation charges, depreciation on implements and farm buildings, interest on working capital, diesel/electricity for operation of pump sets etc., miscellaneous expenses and imputed value of family labour.
