**PENDING DUES OF MGNREGA AND PMAY-G**

1701 SMT. RANJEET RANJAN:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether the Central Government has not yet released the amount of three instalments of MGNREGA to the State of Bihar, which is more than ₹ 2500 crore;
- (b) whether it is also a fact that the amount to be given under Pradhan Mantri Awaas Yojana-Gramin is not being paid in the State;
- (c) whether the development works of the State are not getting hampered due to delay in payments under MGNREGA and Pradhan Mantri Awaas Yojana-Gramin; and
- (d) if so, the State-wise details of the delay in payment under MGNREGA in the country and by when the MGNREGA amount would be paid to the States?

**ANSWER**

(a) & (d): Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is a demand driven wage employment Scheme.

Under Mahatma Gandhi NREGS, States furnish funds release proposals to Government of India. The Ministry releases funds periodically in two tranches with each tranche consisting of one or more installments, keeping in view the “agreed to” Labour Budget, demand for works, opening balance, pace of utilization of funds, pending liabilities, overall performance and subject to submission of relevant documents by the States.

Fund release to the States/UTs is a continuous process and Central Government is committed to making funds available to States/UTs for the implementation of the Scheme as per the demand for work on the ground.

State/UT- wise (including Bihar), details of pending liabilities for material component under Mahatma Gandhi NREGS in the financial year 2022-23 (as on 16.12.2022) is given at **Annexure-I**.

State/UT-wise (including Bihar), details of pending liabilities for wage component under Mahatma Gandhi NREGS as on 16.12.2022 is given at **Annexure-II**.

(b) & (c): Under Pradhan Mantri Awaas Yojana-Gramin (PMAY-G), a total target of 38,62,734 houses had been allocated to the State of Bihar, out of which, 36,93,007 houses have been sanctioned to beneficiaries by the State and 33,66,957 houses have been completed as on 18.12.2022.

Under PMAY-G, the Central Assistance is released to States on the basis of balance targets, committed liabilities, unspent balance available and their compliance to framework for implementation of PMAY-G and directions received from Ministry of Finance from time to time. As on date, Central share of Rs. 27,456.19 crore has been released to State of Bihar for implementation of PMAY-G in the State.

Under Mahatma Gandhi NREGS, 18.65 crore persondays employment has been generated in the State of Bihar as on 19.12.2022 and an amount of Rs. 4631.61 crore has been released to the State of Bihar in the current financial year 2022-23 (as on 16.12.2022). Also the funds are released as per the demand for work on ground under the Scheme.
