- (a): Total Foreign Direct Investment (FDI) inflow of USD 62.38 billion has been reported in the country during the calendar year 2022 (up to September, 2022).
- (b): The sector-wise details of FDI reported through equity inflow in the country during calendar year 2022 (up to September, 2022) are at Annexure-I.
- (c): The State-wise and Union Territory-wise details of FDI reported through equity inflow in the country during calendar year 2022 (up to September, 2022) are at Annexure-II.
- (d): As per published remittance-wise data on department website (<https://dpiit.gov.in/publications/si-news-letters>) on quarterly basis, Flipkart India Private Limited received highest FDI through equity inflow in the country during calendar year 2022 , up to September, 2022.
