**EMPLOYMENT UNDER SKILL INDIA MISSION**

1711. SHRI RANDEEP SINGH SURJEWALA:

**Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:**

- (a) the amount allocated to the Skill India Mission, Nationally, State-wise, year- wise during last five years;
- (b) the number of candidates skilled/trained, year-wise, during last five years under Pradhan Mantri Kaushal Vikas Yojana, Jan Shikshan Sansthan, National Apprenticeship Promotion Scheme and Industrial Training Institutes/Craftsmen Training Scheme;
- (c) the placement percentage attained across the country as well as State level and the Government's placement targets, year-wise, scheme-wise, during last five years; and
- (d) whether Government has evaluated how the focus on short-term courses has led to a high number of certification but low employment rate under the schemes?

**ANSWER**

MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(a) Under Skill India Mission, the Ministry of Skill Development (MSDE) delivers short term skills through Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS) Scheme and National Apprenticeship Promotion Scheme (NAPS) and long term skills under Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs), to all sections of the society India. Since 2015, a comprehensive Skill India network has been created viz PMKVY 1.0, PMKVY 2.0 and PMKVY 3.0 training centres (including Pradhan Mantri Kaushal Kendras), Jan Shikshan Sansthans, Industrial Training Institutes (ITIs) and through various registered enterprises in NAPS scheme. Funds allocated by Ministry of Skill Development and Entrepreneurship (MSDE) for Skill India Mission during the last five (5) years stands at Rs. 15192.79 crore, details of which is at Annexure-I.

(b) The number of candidates skilled/trained, year-wise, during last five years under Pradhan Mantri Kaushal Vikas Yojana, Jan Shikshan Sansthan, National Apprenticeship Promotion Scheme and Industrial Training Institutes/Craftsmen Training Scheme are shown in the table below:

(c) Amongst the schemes of the MSDE, only in the case of the PMKVY, placement was mandatory. So, placement is not tracked in other schemes. However, third party evaluation reports have mentioned about success in terms of placement or increases in income of candidates trained under different schemes. The brief details of the same are as given below:

**PMKVY:** Placement percentage attained across the country at an aggregate as well as state level under PMKVY is attached at **Annexure II (1-2)**. As per the Third Party Evaluation Report on PMKVY 2.0 (2016-20), it was found that average monthly income of PMKVY trained and certified individuals was 15% higher than the comparison group. Moreover, 76% of the candidates acknowledged that after the training, they have better chance of getting employment.

**JSS:** The objective of training imparted under JSS is to link the individuals for gainful livelihood and supplement their family income through self-employment and wage employment. The providing of employment/placement to the beneficiaries is not the mandate of the JSS Scheme. As far as the employment of the JSS scheme beneficiaries is concerned, third party evaluation report of the scheme observed that as an impact of the training programme conducted at JSSs, the self and wage employment and private job have become evident. The usefulness of the scheme would be further evident from the fact that same report has mentioned that 77.05% of the beneficiary trainees have undergone occupational shifts.

**ITIs:** The final report of Tracer Study of ITI Graduates (published in January 2018 by the Ministry of Skill Development & Entrepreneurship, GoI) mentions that 63.5% of total ITI pass-outs got employed (wage+ self, out of which 6.7% are self-employed).

**NAPS:** Since, NAPS is an apprenticeship related scheme, no placement is tracked.

(d) Under PMKVY, Training Centers take all efforts to facilitate placements (wage employment/ Self-employment or Apprenticeship) of certified candidates through multiple initiatives like Rozgar Mela and collaboration with industries/markets. In addition, candidates can also avail benefit of placement through 'ASEEM' portal which brings both candidate and potential employer on IT platform to find potential match between two (Employer and candidate). In the PMKVY 3.0 version, facilitation of wage employment / self-employment / apprenticeship is provided to the certified candidates under the STT component of the scheme. Pradhan Mantri Kaushal Kendras act as nodal Centres at districts for providing self employment support. The schedule of activities related to placements are circulated to District Skill Committees (DSCs) for wider publicity. Training Partners work in coordination with DSC / SSDM (State Skill Development Mission) for placement of the candidates.
