**FUNDS ALLOCATED UNDER PMKVY**

1719. SHRI P. WILSON:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

- (a) the beneficiaries and funds allocated under the Pradhan Mantri Kaushal Vikas Yojana (PMKVY), State-wise;
- (b) whether Government is considering giving a minimum level of stipend till the beneficiary gets a job and if so, how much stipend will be given; and
- (c) the job retention percentage of the youth trained under the concerned scheme across the country, including Tamil Nadu?

(a) Under Pradhan Mantri Kaushal Vikas Yojana (PMKVY), since inception i.e. 2015, as on 30.09.2022, 137.17 lakh candidates have been trained/oriented across the country. The State/UT-wise number of candidates trained/oriented under PMKVY is given at *Column (a) of Annexure*.

PMKVY (except PMKVY 1.0 (2015-16)) has two components, namely, Central component and State component. Under Central component of PMKVY, there is no provision of State-wise funds allocation. Under State component of PMKVY, funds and corresponding physical targets have been allocated to the States for the implementation through State Skill Development Mission (SSDM). The State-wise fund allocated under State component of PMKVY (i.e. 2.0 and 3.0) is given at *Column (b) of Annexure*.

- (b) Under PMKVY, there is no provision of stipend for candidates.
- (c) Ministry does not maintain the data of retention of candidates on the jobs.
