**Will the Minister of Labour and Employment be pleased to state:**

- (a) children enrolled in STCs (Special Training Centres) after 31st March, 2021 which were not mainstreamed as per National Child Labour Project (NCLP) guidelines;**
- (b) the details of the funds for running those STCs which have been opened and children have been enrolled after 31st March, 2021; and**
- (c) the details of the budgetary allocation made State-wise, including Odisha for formation of STCs?**

(SHRI RAMESWAR TELI)**

**(a) & (b): National Child Labour Project (NCLP) scheme was approved for implementation up to 31.03.2021 and since then the NCLP has been subsumed/merged with Samagara Shiksha Abhiyan (SSA) Scheme. The Special Training Centres (STCs), approved prior to 31.03.2021 and which had not completed two years as per NCLP Scheme guidelines, were operational after 31.03.2021. No new STCs under NCLP Project have been approved after 31.03.2021.**

**(c): There is no state - wise allocation of fund at Budgetary Estimate (BE) stage under NCLP Scheme. Funds are released to District Project Societies (DPS) of different States based on the proposal received from them alongwith requisite documents, as prescribed in NCLP Scheme guidelines, viz. Annual Progress Report, Quarterly Progress Report, Utilization Certificate, audited statement etc. The details of budgetary allocation (final grant) and fund released under the National Child Labour Project (NCLP) Scheme during 2021 -22 and 2022-23 is as under:**
