FUNDS ALLOCATED TO PUNJAB STATE COMMISSION FOR WOMEN BY NCW

1752: SHRI VIKRAMJIT SINGH SAHNEY:

Will the Minister of WOMEN CHILD AND DEVELOPMENT be pleased to state:

- (a) the details of Activities vis-à-vis amount provided by the National Commission for Women (NCW) to Punjab State Commission for Women and utilization / status of programme / activities during the last three years and the current year.
- (b) whether the National Commission of Women is planning to allocate funds to Punjab State Commission of Women in upcoming year;
- (c) if so, the details thereof and if not, the reasons therefor; and
- (d) the details of fund allocation to various State Women Commissions, State-wise?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SMT. SMRITI ZUBIN IRANI)

(a) to (c): NCW is an apex body mandated to safeguard interests of women across country. NCW does not have any other branch or subordinate bodies; the Commission carries out its various initiatives in collaboration with other establishments, such as State Commissions for Women (SCsW), institutions and other organisations.

The NCW, from time to time, calls for proposals for conducting Research Studies, Awareness programmes, Seminars, consultations, workshops, etc. on various identified issues pertaining to Women. Thereafter, on the basis of the proposals received, the Commission extends financial assistance for the programme.

In the case of Punjab State Commission for Women, financial assistance have not been provided for any project in the last 3 years and in the current year, as no proposal has been received.

(d): The details of State-wise funds allotted to various State Commissions for Women by NCW during last three years including Current Year is annexed as **Annexure 'I'**.
