1994 SHRI PABITRA MARGHERITA:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) the total budget allocated to the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) since its inception, year-wise;
- (b) the objectives of this scheme;
- (c) the total number of beneficiaries of this scheme till date, State-wise; and
- (d) the total funds disbursed by Government under this scheme?

A N S W E R MINISTER OF STATE FOR MINISTRY OF RURAL DEVELOPMENT AND CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SADHVI NIRANJAN JYOTI)

- (a): Under, Pradhan Mantri Garib Kalyan Anna Yojana (PM-GKAY), about 1118 LMT foodgrains have been allocated with an earmarked total financial outlay of approximately Rs.3.91 Lakh Crore. Year wise budget allocation for PMGKAY is at **Annexure I.**
- (b): In the wake of COVID-19 outbreak in the country in March 2020, the Department pursuant to the announcement of the pro-poor 'Pradhan Mantri Garib Kalyan Package (PMGKP)' by the Government of India, had started the distribution of 'additional' and 'free-of-cost' foodgrains (Rice/Wheat) to around 80 Crore National Food Security Act (NFSA) beneficiaries in the country under the "Pradhan Mantri Garib Kalyan Anna Yojana (PM-GKAY)" to ameliorate the food security hardships faced by the poor and needy due to unprecedented outbreak of the pandemic, lockdowns and thus the economic disruptions caused across the country.

The additional foodgrains are distributed at the scale of 5 Kg per person per month, over and above their regular monthly NFSA foodgrains (i.e., monthly entitlement of their respective NFSA ration cards) as a measure to ensure that no poor, vulnerable or needy beneficiary/ beneficiary household suffers due to non-availability of foodgrains during the pandemic induced economic crises.

- (c): All 80 crore (approximately) NFSA beneficiaries are covered under PM-GKAY. Statewise list of NFSA beneficiaries is attached at **Annexure-II**.
- (d): This scheme is completely funded by Central Govt. including all expenses towards transportation, dealer margin, etc. Financial Outlay and subsidy incurred by Government of India is at Annexure-I.
