- (a) the number of beneficiaries under the National Food Security Scheme (NFS) in various States of the country, including Uttarakhand during the last two years;
- (b) the quantity of foodgrains allocated and distributed and the number of families benefitted by it after the announcement of free distribution of foodgrains during the lockdown in COVID-19 period, State-wise; and
- (c) the present status of 'One Nation One Ration Card' scheme?

(a): A statement indicating the State/Union Territory (UT)-wise number of beneficiaries covered under the National Food Security Act, 2013 (NFSA) during the last two years is at **Annexure-I.**

(b): In view of the outbreak of Covid-19, Central Government has allocated foodgrains to all the States/UTs for about 80 crore persons under Pradhan Mantri Garib Kalyan Anna Yojana (PM-GKAY), for distribution among beneficiaries covered under the NFSA (i.e. Antyodaya Anna Yojana and Priority Category Households). Under the PMGKAY, the households covered under the NFSA are entitled to receive 5 kg of foodgrains (rice / wheat) per person per month, free of cost. The entitlement of foodgrains under PM-GKAY is in addition to their entitlement under NFSA (i.e. 35 kg of foodgrains per month per AAY household and 5 kg of foodgrains per person per month for Priority Households @ Rs.3/2/1 per kg for rice/ wheat/ coarsegrains).

In addition to this, as part of the Economic measures (AtmaNirbhar Bharat), allocation of foodgrains, free of cost, had been made available to all the States/Union Territories, for the month of May and June, 2020, for stranded migrants who were not covered under the National Food Security Act, 2013 or any other State scheme. Such beneficiaries were eligible for 5 kg of foodgrains per person per month. Identification of such beneficiaries and distribution of foodgrains to them was the responsibility of concerned State Government or Union Territory Administration.

A statement indicating the State/UT-wise allocation of foodgrains under the PMGKAY and ANB is at **Annexure-IIA** to **Annexure-IIB** respectively.

(c): The One Nation One Ration Card (ONORC) plan, for nation-wide portability of the NFSA benefits, is presently enabled in all the 36 States/UTs, covering entire NFSA population (around 80 Crore NFSA beneficiaries) in the country. Under the plan, the NFSA beneficiaries have been empowered with the choice to lift their entitled foodgrain from any Fair Price Shop (FPS) of their choice, anywhere in the country, by using their existing ration card with biometric authentication on an electronic Point of Sale (ePoS) device.
