- (c) whether FCI stores its foodgrains in rented warehouses also, if so, the amount being spent annually on the same;
- (d) the total quantity of foodgrains wasted in FCI's own and rented warehouses during the last five years, State/warehouse-wise;
- (e) whether Government has fixed any accountability for such wastage by FCI; and
- (f) if so, details thereof and the action taken in this regard so far, State-wise?

- (a): As on 01.12.2022, Covered storage capacity of 353.60 Lakh MT is available with Food Corporation of India (FCI) (Owned & Hired). State-wise details are at Annexure-I.
- (b): Yes, Sir. Details of storage facilities augmented /modernized by FCI in the last four years under the various schemes are given below:
 - (i) 1 silo developed in Katihar with capacity of 0.50 LMT in last four years and current year, under Public Private Partnership (PPP) mode.
 - (ii) 3 godowns have been created with capacity of 0.25 LMT in last four years and current year under Private Entrepreneurs Guarantee (PEG) Scheme.
