298# MS. SAROJ PANDEY:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government has devised any action plan to develop new tourist places and to augment facilities at old tourist places in the country;
- (b) if so, the number of projects that have been approved in the States of Chhattisgarh, Jharkhand and Odisha under this action plan; and
- (c) the quantum of funds approved by the Central Government for this purpose?

ANSWER

THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) to (c): Identification and development of tourist places is primarily the responsibility of the State Governments/Union Territory Administrations. However, the Ministry of Tourism has provided financial assistance under the 'Swadesh Darshan' and 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' Schemes for the development of tourism related infrastructure in the States/Union Territories.

Ministry of Tourism has also sanctioned projects under the 'Assistance to Central Agencies for Tourism Infrastructure Development' Scheme for the development of tourism related infrastructure in the States/UTs.

The list of projects sanctioned under the above schemes in the country including the States of Chhattisgarh, Jharkhand & Odisha is given at **Annexure**.
