(a) & (b): ‘Police’ and ‘Public Order’ are State subjects under the Seventh Schedule to the Constitution of India. The responsibilities to maintain law and order, protection of life and property of the citizens including investigation and prosecution of crime against citizens rest with the respective State Governments. The State Governments are competent to deal with such offences under the extant provisions of laws. The National Crime Records Bureau (NCRB) compiles and publishes statistical data on crimes in its publication “Crime in India”. The latest published report is for the year 2021. The State/UT-wise details on total number of incidents of crime/atrocities against Scheduled Castes (SCs) as per cases registered in the years 2018-2021 are at Annexure-I. Details on total number of cases convicted out of cases which have completed trials for crime/atrocities against Scheduled Castes (SCs) for the years 2018-2021 are at Annexure-II.
