Will the Minister of FINANCE be pleased to state:

- (a) The total amount of external debt of States, State-wise
- (b) The details of the development projects in the State of Andhra Pradesh that are being funded by external borrowing from multilateral agencies; and
- (c) The amount of guarantees given by the Union Government to the external debt of States?

ANSWER

THE MINISTER OF STATE FOR FINANCE (SHRI PANKAJ CHAUDHARY)

(a) Article 293 (1) of the Indian Constitution mandates that the State Governments in India can borrow only from internal sources. Thus, only Government of India can incur external debt, including that which is meant for the projects and programmes of particular States. Accordingly, the State-wise external debt is presented in the following table.
