‘PROJECTS UNDER PMKSY IN WEST BENGAL’

259. SHRI ABIR RANJAN BISWAS:

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) the number of projects sanctioned and made functional under the Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) in West Bengal in the last three years, year-wise;
- (b) the number of employment opportunities created under the above projects in last three years, year-side;
- (c) whether there is an unacceptable wastage of agricultural produce which otherwise can be used in processing;
- (d) if so, the efforts made by the Government to approve more projects so as to reduce wastage and push the percentage of processing in the country; and
- (e) the details of backward and forward linkages created under PMKSY in last three years, year wise, and State wise?

(a) & (b): The Ministry of Food Processing Industries (MoFPI) is implementing an umbrella scheme, namely Pradhan Mantri Kisan Sampada Yojna (PMKSY) consisting of various sub-schemes. The number of projects sanctioned and project made functional in the State of West Bengal as well as number of employment opportunities created under the sub-schemes of PMKSY are as under:

(d): MoFPI has been making concerted efforts to augment the level of food processing in the country and thereby help in reducing the wastage of agri-horti produce. Besides implementing PMKSY, as detailed out in reply to part-(a) & (b) above, MoFPI is also implementing Pradhan Mantri Formalisation of Micro Food Processing Enterprises (PMFME) Scheme and Production Linked Incentive (PLI) Scheme towards this objective.

Under PMKSY alone, MoFPI has so far approved 1098 projects under different sub-schemes of PMKSY, targeting creation of processing capacity of 292.907 lakh metric tonnes (LMT)/annum and preservation capacity of 75.678 LMT/annum.
