PROMOTION OF TOURISM IN JAMMU AND KASHMIR

2698 SHRI GULAM ALI:

Will the Minister of **TOURISM** be pleased to state:

- (a) the specific schemes promoting tourism in tribal dominated areas;
- (b) the details of employment generated among tribal people by such schemes during the last five years;
- (c) the number of proposals under PRASHAD Scheme received from Jammu and Kashmir and the status thereof;
- (d) the reasons for Purmandal-Uttervahini development project under PRASHAD scheme still awaiting clearance;
- (e) the budget allocated for development of tourism in Jammu, Doda, Kishtwar, Poonch and Rajouri districts and for Kashmir region, year-wise since 2018; and
- (f) the status of schemes for pilgrimage tourism?

ANSWER

THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a): The major schemes implemented by the Ministry of Tourism on PAN India basis including tribal dominated areas for development and promotion of tourism are:

- i. Swadesh Darshan
- ii. Pilgrimage Rejuvenation and Spiritual Heritage Augmentation Drive (PRASHAD)
- iii. Assistance to Central Agencies for Tourism Infrastructure Development
- iv. Domestic Promotion and Publicity including Hospitality
- v. Restructured Scheme of Overseas Promotion & Publicity including Market Development Assistance
- vi. Assistance to IHMs/FCIs/IITTM/ICI/ NCHMCT etc.
- vii. Capacity Building for Service Providers
- viii. Champion Services Sector Scheme
- ix. Safe Tourist Destinations for Women

(b): Community-wise tourism employment data is not maintained by Ministry of Tourism. However, as per estimation in accordance with 3rd Tourism Satellite Account (TSA), the contribution of tourism to the total employment of the country for year 2016-17, 2017-18, 2018-19, 2019-20 and 2020-21:

(d): The Ministry of Tourism has sanctioned projects under the PRASHAD Scheme, subject to receipt of proposals from the State Governments/UT Administrations, adherence to the scheme guidelines, submission of suitable detailed project reports, availability of funds and utilization of funds released earlier.

(e): The Ministry of Tourism has provided financial assistance for development of theme based tourism circuits under the 'Swadesh Darshan' Scheme in the Union Territory of Jammu & Kashmir and Union Territory of Ladakh. Projects have also been sanctioned under the 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' Schemes for the development tourism related infrastructure in the UT of Jammu & Kashmir. The details of the projects sanctioned under the above mentioned schemes is at **Annexure-I**.

(f): The Ministry of Tourism has sanctioned projects on the themes of Buddhist, Ramayana, Tirthankar, Krishna and Spiritual under the Swadesh Darshan Scheme. In addition, projects have also been sanctioned at identified pilgrimage sites under the PRASHAD Schemes. The details of the projects sanctioned under the above themes of Swadesh Darshan Scheme and the PRASHAD Scheme is at **Annexure-II**.
