Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

(a) the year-wise, season-wise amount released/premium paid by Government under Pradhan Mantri Fasal Bima Yojana (PMFBY) to the public and private insurance companies separately since February 2018 till date;

(b) the compensation in crores paid under PMFBY to farmers as insurance, since February 2018 till date, year-wise, season-wise;

(c) the list of States not implementing the PMFBY; and

(d) whether there has been a CAG audit of the scheme in past five years, if not, the reasons thereof?

(a) & (b): Season-wise details of Government share in premium and claims paid by public and private general insurance companies separately from Kharif 2018 to Rabi 2021-22 season are given in **Annexure**.

(c): At present, Arunachal Pradesh, Bihar, Gujarat, Jharkhand, Meghalaya, Mizoram, Nagaland, Punjab, Telangana, West Bengal, States and Union Territories of Chandigarh, Dadra & Nagar Haveli and Daman & Diu, NCT of Delhi, Laddakh and Lakshadweep are not implementing the PMFBY.

(d): Annual Audit of the Department of Agriculture and Farmers Welfare including Pradhan Mantri Fasal Bima Yojana (PMFBY) is conducted by the C & AG.
