- (b) number of displaced people who got permanent job in Coal India Ltd./Operating Company; and
- (c) number of CBSE-ICSE schools being run in the collieries with direct-indirect help from the said operating company and percentage of seats reserved for children of the displaced persons, the number of children of such displaced families who were educated in those schools during the said period?

- (a): The year-wise, State-wise and colliery-wise details of the number of families and persons displaced by land acquisition in Coal India Limited and its subsidiaries under the Coal Bearing Areas (Acquisition and Development) Act, 1957 during the last three years and the rate at which the land was acquired is given at **Annexure**.

1	ECL		There is no separate provision for reservation of seats in the schools for education to children of displaced persons. However, priority is given to those children for admission in these schools on first cum first service basis.
2	BCCL		CBSE schools are operating in Command Area of BCCL and use the infrastructure of the said subsidiary. The Students in these schools are both from BCCL family as well as outsiders. Many of the outsider students are from displaced families. There is no such reservation for the children of displaced families.

3	CCL	13	There is no provision in admission for keeping the seats reserved for the displaced person's children. But preference is given for admission of children of displaced person in schools desired by the parents.
4	WCL	5	Admission are being provided to the displaced persons children, however no reservation of seats is available for the children of the displaced families.
5	SECL	16	Total nos. of 10071 students of non SECL dependents. The major share of Non-SECL employees dependent student consist of the children from displaced families. It is also informed that subsidised fee is payable by the children from displaced families which is at par with the fee payable by the children of employees of SECL.
6	NCL	13	The fee of 10 NCL funded schools is subsidized and lower than the private schools running in vicinity. The children of displaced person are also being provided admission in these schools. Total 11,174 children of non-employee wards are being educated.
7	MCL	14	There is no reservation of seats for the wards of displaced families; however, preference in admission is given by those schools for the wards of such displaced families who have got permanent employment in MCL. During the 2022-23, 62 wards of displaced families educated in MCL and from 2009-10 to 2021-22, Total no. of 6737 ward of displaced family educated.
