- (b) if so, whether auctions for the same have been invited;
- (c) if so, the details thereof and the number of bids accepted by Government; and
- (d) if so, the details of the new licence issued and spectrum sold as a result thereof?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (DR SHAKEEL AHMAD): (a) to (d) The Government has decided to grant new Unified Access Services (UAS) Licences as per the existing policy. Selling/auction of 2G spectrum is not envisaged under telecom access services licences.

No new Letter of Intent for UAS Licence has been issued after 5 th March, 2007.

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (DR. SHAKEEL AHMAD): (a) Sir, the number of telephone connections provided in Vasundhara Exchange area of Ghaziabad, U.P. by the BSNL during the last two years is given below:

(b) No request received prior to July 2007 is pending for installation of telephone connection in Vasundhara telephone exchange area of BSNL. From August 2007 onwards till date, 16 cases are pending. Details are given in the enclosed Statement. (See below).

(c) and (d) No, Sir. Installation of telephone connections is not restricted due to non-provision of cables. Working out the requirement of UG Cable pairs based on the demand for telephone connections and availability of cable pairs is done on regular basis. Thereafter, planning for laying of UG Cable, ordering for UG Cable and actual laying of UG Cable is done. Thus, though review of external plant and associated activities are undertaken for provision of telephone connections on demand, yet some of the area under an exchange becomes technically non-feasible pending laying and commissioning of UG cable. However, these subscribers will be provided with telephone as per the dates shown in the Annexure.
