- (a) the number of Gram Panchayats in the country which have formulated their Development Plans in accordance with Government, State-wise details thereof;
- (b) the total number of activities planned for these villages and the State-wise number of activities completed; and
- (c) the details of funds spent by Government so far to electronically modernize Panchayats under various schemes across the country?

- (a) & (b): State wise details of Gram Panchayat Development Plan(GPDP) along with the number of activities sanctioned, completed and ongoing as reported by States for the plan year 2022-23 is at **Annexure**.
- (c) Under Digital India Programme, Ministry is implementing e-Panchayat Mission Mode Project (MMP) with the aim to transform the functioning of Panchayati Raj Institutions (PRIs), making them more transparent, accountable, and effective. The Ministry launched eGramSwaraj, a work-based Accounting Application for Panchayati Raj Institutions under the e-Panchayat MMP on 24th April 2020. This application encompasses all aspects of Panchayat functioning viz. planning, budgeting, accounting, monitoring, asset management etc., on a single digital platform including online payments.

Under e-Panchayat MMP funds are being provided to National Informatics Center Services Inc. (NICSI) for central level support for maintenance of e-Panchayat applications. In 2022-23, the expenditure on e-Panchayat MMP is Rs.15crore.
