Will the Minister of **TOURISM** be pleased to state:

- (a) the details of places included for development as cultural and religious circuits under the Swadesh Darshan Scheme;
- (b) whether Government is planning to develop tourism circuits for Shiva temples in the State of Uttarakhand under the Swadesh Darshan Scheme;
- (c) if so, the details thereof; and
- (d) the details of funds allocated and spent in Uttarakhand under this Scheme during the last five years?

ANSWER

THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) to (d): The Ministry of Tourism has sanctioned 76 projects for Rs.5292.57 Crore in identified themes under its Swadesh Darshan scheme (SDS). The details of the projects sanctioned under this scheme including the project sanctioned in the State of Uttarakhand and also under the theme of 'Spiritual', 'Ramayana', 'Krishna', 'Buddhist', 'Tirthankar' and 'Heritage' is annexed.

The Ministry of Tourism has now revamped the SDS as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable and responsible tourist destinations and has identified 'Pithoragarh' and 'Champawat' in Uttarakhand for development.

The Ministry of Tourism under its 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' also provides financial assistance to the State Governments/Union Territory Administrations, with the objective of integrated development of identified pilgrimage and heritage destinations and has sanctioned a project 'Integrated Development of Kedarnath' in Uttarakhand in the year 2015-16 for Rs.34.77 Crore.
