EFFICACY OF ASEEM PORTAL IN ODISHA AND DELAY IN THE ESTABLISHMENT OF ALLOCATED PMKKS

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

- (a) the current status of working of Aatmanirbhar Skilled Employee-Employer Mapping (ASEEM) portal, launched in July 2020;
- (b) total number of registrations attained on the portal, State-wise/UT-wise since 2020;
- (c) the total number of hirings happened through ASEEM Portal with special reference to Odisha;
- (d) the reasons for delay in establishing Pradhan Mantri Kaushal Kendras (PMKKs) only 722 across 632 districts as against the allocated PMKKs i.e. 818 across 707 districts;
- (e) the total number of beneficiaries (candidates) trained in established PMKKs till date, Statewise/UT-wise; and
- (f) measures taken by Government to undo delay in the establishment of PMKKs to achieve the set target?

- (a) Aatmanirbhar Skilled Employees Employer Mapping (ASEEM) portal, a directory of skilled workforce, is available for users and the portal is envisaged to be subsumed in Skill India Digital.
- (b) As on 31.03.2023, there is around 29 lakh data of candidates available on ASEEM. The Statewise details of candidates are not available.
- (c) The ASEEM Portal is a platform that matches supply of skilled workforce with the market demand, thereby facilitating better livelihood opportunities for youth including migrants and availability of ready skilled manpower to employers. ASEEM was never envisaged as a Placement Portal, but developed for mapping the Skilled Candidates with Employers.
- (d) The reason for the delay in the establishment of PMKKs was mainly due to operational challenges faced by the training partners because of the COVID-19 pandemic.
- (e) The State-wise number of beneficiaries (candidates) trained in PMKKs under Pradhan Mantri Kaushal Vikas Yojana (PMKVY) are placed at **Annexure**.
- (f) The Ministry has taken various measures to undo delay in the establishment of PMKKs. Continuous monitoring and follow up are being done for setting-up of PMKKs. National Skill Development Corporation under the aegis of Ministry conducted a series of consultative workshops to identify the corrective measures to improve the sustainability of PMKKs.
