### GENDER SPECIFIC PLACEMENTS UNDER THE PMKVY SCHEME 3.0

#### 2517 SMT. SULATA DEO:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

- (a) the details of the candidates, male, female, and non-binary trained/oriented under Pradhan Mantri Kaushal Vikas Yojana Phase 3 (PMKVY 3.0), State-wise, in the years 2021 and 2022;
- (b) the details of the placements offered to the candidates skilled and formalised under the PMKVY 3.0 in the last two years, State-wise and gender-wise;
- (c) whether Government is aware about the low placement rate of the program; and
- (d) if so, the details thereof, and the plans to improve on this account?

### **ANSWER**

- (a) The State/UT-wise candidates (male, female and non-binary) trained/oriented under Pradhan Mantri Kaushal Vikas Yojana Phase-3 (PMKVY 3.0) during the years 2021 and 2022 is given at **Annexure I**.
- (b) PMKVY had two components namely Short Term Training (STT) and Recognition of Prior Learning (RPL). Placement opportunities were facilitated to STT certified candidates, while RPL was not linked with placements as it recognized the existing skills of candidate. Under the Short term training (STT) component of PMKVY 3.0, successfully certified candidates provided with placement opportunities. The State/UT-wise and gender-wise number of candidates reported placed under PMKVY 3.0 during the last two years (i.e. 2021-22 and 2022-23) are given at **Annexure II**.
- (c) Despite disruption caused due to COVID-19 pandemic, as on 31.12.2022, around 1.14 lakh candidates had been certified under the STT component of PMKVY 3.0 Out of STT certified candidates, around 33 thousand candidates were reported placed.

(d) Under PMKVY 3.0, Ministry had facilitated the placement for the short term training (STT) certified candidates through various initiatives such as organization of Rozgar Melas, incentivization of placement, etc. Rozgar Melas are organized with the support of Sector Skill Councils, training providers and implementing agencies to directly link the candidates with the potential employers. In addition, Ministry has launched the Aatmanirbhar Skilled Employees Employer Mapping (ASEEM) portal, which acts as a central directory of skilled workforce registered and certified under Skill India Portal (SIP), across all schemes at central and state level. Also, Ministry is implementing National Apprenticeship Promotion Scheme (NAPS) to promote apprenticeship training at establishments/industries across the country.
