**Aquaculture ecosystem in Odisha**

Will the Minister of **FISHERIES, ANIMAL HUSBANDRY AND DAIRYING** be pleased to state:

- (a) whether Government seeks to promote the thriving aquaculture ecosystem in Odisha;
- (b) If so, the details thereof, if not, the reasons therefor; and
- (c) the figures pertaining to the number of registered aquaculture facilities in Odisha, district wise?

**ANSWER**

(a) & (b): The Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying under “Pradhan Mantri Matsya Sampada Yojana (PMMSY)” during the last two financial years (2020-21 and 2021-22) and the current financial year (2022-23) has accorded approvals to the proposals of Government of Odisha at a total cost of Rs.631.13 Crore for development of fisheries and aquaculture in the State of Odisha. The major activities approved under PMMSY to Odisha for promotion of aquaculture are establishment of hatchery for production of quality seed for fresh water and brackish water aquaculture, expansion of area and technology intervention in aquaculture to increase fish production, integrated development of reservoir and installation of cages in reservoir to increase productivity of reservoir, establishment of fish feed mill, disease diagnostic and quality testing laboratory for health management in aquaculture. Around 33000 hectare of potential areas available for coastal aquaculture in the State of Odisha. Out of that 15130.53 hectare is under operation. The brackish water shrimp production in Odisha has increased from 6149 tonne in the year 2009-10 to 50661 tonne in the year 2021-22.

(c): District wise registered brackish water aquaculture facilities available in the State of Odisha as reported by Coastal Aquaculture Authority (CAA) furnished at Annexure-I.
