RELIEF PACKAGE FOR TEXTILES INDUSTRY IN PANIPAT

3513. LT.GEN. (DR.) D. P. VATS (RETD.):

Will the Minister of TEXTILES be pleased to state:

- (a) the details of textile industries shut down in Panipat over failure to meet the pollution norms set by the Commissioner for Air Quality Management (CAQM) from 2020 till now, year-wise; and
- (b) whether Government has brought out any specific relief package for the affected industries?

ANSWER

THE MINISTER OF STATE FOR TEXTILES (SMT. DARSHANA JARDOSH)

(a): In order to abate air pollution from major contributing sources and enforcement of various statutory directions, orders, rules, regulations and notifications to this effect, a total of 07 Textile industries located in Panipat have so far been issued temporary Closure directions by the Commission for Air Quality Management (CAQM) in NCR and Adjoining Areas for gross violations and failure to meet the air pollution norms/ standards etc as detailed under:
