#### QUANTUM OF FOOD GRAINS IN STORAGE

#### 2002 SHRI SHAKTISINH GOHIL:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) the quantum of food grains currently available in storage across the country as on date;
- (b) details of the number of silo sites under development, including the current status of each site, respective estimated storage capacity, and estimated date of completion; and
- (c) details of the progress made as on date towards the goal of doubling India's silo capacity under Public-Private Partnership by 2019-29 to 15 lakh tonnes?

# A N S W E R MINISTER OF STATE FOR MINISTRY OF RURAL DEVELOPMENT AND CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SADHVI NIRANJAN JYOTI)

- (a): The stock of foodgains in Central Pool as on 1<sup>st</sup> March, 2023 is 327.24 Lakh Metric tons (LMT).
- (b) & (c): In order to upgrade and modernize the storage facilities, Government of India approved Action Plan for construction of steel silos on PPP (Public Private Partnership) mode in the country. Under this plan Silos with capacity of 24.25 LMT at various locations throughout country are under implementation. Out of which a capacity of 12.75 LMT is completed and remaining is under various stages of development

Further, silo capacity of 111.125 LMT in PPP mode is proposed under Hub & Spoke model to be implemented in 3 phases. In phase-I tenders for 10.125 LMT at 14 locations on FCI own land have been awarded and in respect of 24.75 LMT at 66 locations on private land have been awarded.

The details of completed, under construction silos across the country at present are at Annexure-I.
