STEEP HIKES IN AERONAUTICAL CHARGES BY AIRPORTS RUN BY PRIVATE COMPANIES

2093. SHRI BINOY VISWAM

Will the Minister of CIVIL AVIATION be pleased to state:-

- (a) the details of the hike in aeronautical charges like User Development Fees (UDF), parking fees, and landing fees as approved by the Airports Economic Regulatory Authority (AERA) for airports leased to private companies since 2019, airport-wise and year-wise;
- (b) the details of stakeholder consultations that were organized before the AERA approved a hike in aeronautical charges since 2019, airport-wise and year-wise; and
- (c) details of the factors taken into consideration by the AERA when private companies propose a hike in aeronautical charges?

ANSWER

Minister of State in the Ministry of CIVIL AVIATION (GEN. (DR) V. K. SINGH (RETD))

(a): Since 2019, Airports Authority of India has leased out six of its airports namely Ahmedabad, Jaipur, Lucknow, Guwahati, Thiruvananthapuram and Mangaluru through Public Private Partnership (PPP) for operation, management and development on long term lease basis. Out of these airports, Airports Economic Regulatory Authority of India (AERA) has determined aeronautical tariff for Mangaluru and Ahmedabad airports. The year-wise details of the aeronautical charges like User Development Fees (UDF), Parking fees, and Landing fees for these two airports is at Annexure-I.

- (b): Details of stakeholders consultation held in respect of Mangaluru and Ahmedabad Airports are at Annexure-II.
- (c): AERA has a mandate to determine tariff for aeronautical services rendered at Major Airports. AERA determines aeronautical charges of 'major' airports such as Landing, Parking, Housing, & UDF etc. for a five year control period, inter-alia considering the factors such as Return on investment, Operating expenditure, Depreciation and Taxes.
