Price of subsidised and non-subsidised LPG cylinders

465 Shri Mallikarjun Kharge:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) the details of the price of subsidised and non-subsidised LPG cylinders in the last five years, year-wise;
- (b) the details of funds allocated and utilised for Direct Benefit Transfer-LPG Scheme in the last five years, year-wise;
- (c) whether Government is providing subsidy on LPG cylinders;
- (d) if so, the number of beneficiaries in the last five years, year-wise and State-wise; and
- (e) if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS
(SHRI RAMESWAR TELI)

(a) to (c): Subsequent to the implementation of DBTL (PAHAL) Scheme, 2014, the price of a domestic LPG cylinder is same for all consumers in a market. Subsidy, as admissible, is directly credited to the bank accounts of eligible beneficiaries.

The prices of petroleum products including LPG in the country are linked to the price of respective products in the international market. However, Government continues to modulate the effective price of domestic LPG. Public Sector Oil Marketing Companies have suffered huge losses on sale of domestic LPG. To compensate these losses, the Government has recently approved a one-time compensation of Rs. 22000 crore to OMCs. Government has started a targeted subsidy of Rs. 200 per 14.2 Kg cylinder for Pradhan Mantri Ujjwala Yojana (PMUY) beneficiaries for upto 12 refills for year 2022-23.

The details of the price of 14.2 kg domestic LPG cylinder at Delhi in the last five years are given at **Annexure**.

Subsidy, as admissible, is credited to the bank accounts of eligible beneficiaries under DBTL. Further, w.e.f. 21st May, 2022, the Government has started a targeted subsidy of Rs.200 per 14.2 Kg cylinder for Pradhan Mantri Ujjwala Yojana (PMUY) beneficiaries for upto 12 refills a year for year 2022-23.
