- (a) the number of people who benefited under the Pradhan Mantri Awaas Yojana (Gramin) (PMAY-G) in the State of Karnataka so far and the target set for the year 2021-22 in the country, State-wise/ UT-wise;
- (b) whether the budget earmarked for the aforesaid scheme remains unutilized for the financial year 2021-22;
- (c) if so, the details thereof and whether any challenges are faced by the Ministry; and
- (d) if not, the details of utilization of the allotted budget, State-wise?

- (a) Under Pradhan Mantri Awaas Yojana- Gramin (PMAY-G), houses have been sanctioned to 1,63,243 beneficiaries in the State of Karnataka out of which 1,01,678 houses have already been completed. 3,60,824 pending houses have been completed under erstwhile Indira Awaas Yojana, in addition to PMAY-G houses. The State-wise/Union Territory (UT)-wise targets allocated under PMAY-G in 2021-22 is given in Annexure-I.
- (b) & (c) No Sir.
- (d) Against the allocated budget of Rs.30,057.15 crores in FY 2021-22 under PMAY-G, an amount of Rs.30,056.87 crores (99.99%) has been utilized. This includes an amount of Rs. 26,237.24 crores released to the States/UTs for implementation of PMAY-G. The State/UT wise funds released under PMAY-G in FY 2021-22 and funds utilized by States/UTs (including State share), is given in Annexure-II.
