#### UNIFORMITY IN DIGITAL RECORDS

#### 581 SHRI S NIRANJAN REDDY:

Will the Minister of **HEALTH and FAMILY WELFARE** be pleased to state:

- (a) whether it is a fact that Electronic Health Record Policy is facing significant interoperability challenges due to a difference in interpretations of the term "digitizing records" by different hospitals;
- (b) the steps taken by the Union Government to ensure uniformity in managing digital records by hospitals across the country; and
- (c) the list of health records digitalised in urban and rural areas in the last three years, under the Electronic Health Record Policy, State-wise?

#### **ANSWER**

# THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

- (a) to (c) MoHFW has notified Electronic Health Record (EHR) Standards Version 2016 for India in December 2016 (whilst the earlier version of EHR Standards was notified in September 2013) with the intent to bring standardisation and homogeneity, inter-operability in capture, storage, transmission and better decision support system of healthcare information across various Health IT systems. This helps in reducing expenditure on avoidable repetitive and similar diagnostic tests & ensuring continuity of care. Various efforts have been taken to ensure uniformity in managing digital records in the country:
  - To accelerate and promote the adoption of the notified EHR standards and interoperability between health systems, Ministry has set up the National Resource Centre for EHR Standards (NRCeS) in 2017 at C-DAC Pune.
  - Ministry has published the National Digital Health Blueprint (NDHB) as an architectural framework to create national digital health ecosystem across the country.
  - In order to ensure interoperability of health records and principles of NDHB, the Ayushman Bharat Digital Mission (ABDM) was launched by the Government of

India, initially as a pilot in six Union Territories on Aug 15, 2020 and thereafter, nationally on September 27, 2021. ABDM aims to promote interoperability and connectivity between hundreds of different, disparate existing digital health systems. This is done by way of certain core building blocks or modules such as registries of individuals/citizens/patients (Health ID registry), registry of healthcare professionals (Healthcare Professionals Registry) and registry of healthcare facilities including hospitals, laboratories, pharmacies, etc (Health Facility Registry).

• In these registries, each of these entities is provided with a unique identifier across the ecosystem. In addition to registries, NHA has also developed a digital system called Health Information Exchange and Consent Manager (HIE-CM). This system ensures that the identity of persons intending to share information is first verified, consent of the person/patient is taken, logged and only after that, the health records are shared. ABDM follows the EHR standards prescribed by National Resource Centre for EHR Standards (NRCeS).

State/UT year-wise digital health records since inception linked to the ABHA (Ayushman Bharat Digital Health Account)/ ABHA Address as part of the ABDM ecosystem is annexed herewith.
