RASHTRIYA GRAM SWARAJ ABHIYAN (RGSA) IN PUNJAB

717. SHRI VIKRAMJIT SINGH SAHNEY:

Will the Minister of PANCHAYATI RAJ be pleased to state:

- (a) the details of the funds allocated and utilized for Rashtriya Gram Swaraj Abhiyan (RGSA) in last three years, year-wise, State-wise, district-wise for Punjab;
- (b) the number of rural local bodies which achieved the Sustainable Development Goals (SDG) in last three years, year-wise, State-wise, district-wise for Punjab;
- (c) whether Government has conducted any regular yearly impact evaluation study on Rashtriya Gram Swaraj Abhiyan (RGSA), if so, year-wise details of the report of last three years;
- (d) if not, the reasons therefor; and
- (e) the number of personnel in Panchyati Raj Institutions trained under the scheme in last one year, State-wise, district-wise for Punjab?

ANSWER

(a) Ministry implemented the scheme of Rashtriya Gram Swaraj Abhiyan (RGSA) during 2018-19 to 2021-22. As per the available information, details of the funds allocated and utilized under the scheme during the last three years by the State of Punjab is as under:

Since the funds are mainly for capacity building and training programs, which are coordinated by the State Panchayati Raj and Rural Development Department, there is no district-wise allocation of funds.

(b) Ministry is implementing the Centrally Sponsored Scheme of revamped RGSA approved for implementation from 2022-23 to 2025-26 to develop governance capabilities for Gram

Panchayats (GPs) to deliver on Sustainable Development Goals (SDGs) through localization at the grassroots level. To give the impetus to Localization of Sustainable Development Goals (LSDGs) at Panchayats, GPs are preparing thematic and convergent Gram Panchayat Development Plan (GPDP) based on the Sankalp taken by GP on nine themes of LSDGs from 2022-23 onwards. A maximum of three Sankalp can be taken by each GPs. District wise details of Sanklap taken by GPs is attached as Annexure.

- (c) & (d) Third Party Evaluation of erstwhile RGSA scheme had been done and recommendations contained in evaluation report suitably incorporated in the Centrally Sponsored Scheme of Revamped RGSA approved for implementation from 2022-23 to 2025-26.
- (e) As reported by State, a total of 37,446 Elected Representatives and functionaries were trained under the scheme in last one year.
