USE OF WASTE MATERIAL IN CONSTRUCTION OF NHS

723. SHRI V. VIJAYASAI REDDY:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:

- (a) whether it is a fact that Andhra Pradesh is one of the leading States where plastic is extensively being used for construction of National Highways;
- (b) if so, details thereof, State-wise, during the last five years, year-wise;
- (c) status of use of fly ash, iron and steel slag, construction and demolition waste in construction of NHs; and
- (d) efforts being taken by Government for use of above mentioned waste extensively in NHs?

ANSWER

- (a) & (b) State-wise and year-wise length of National Highways built using waste plastic including in the State of Andhra Pradesh is annexed.
- (c) More than 359 lakh Metric Ton (MT) fly ash and 7.28 lakh MT construction and demolition (C&D) waste has been used in construction of National Highways. Length of National Highways constructed using iron and steel slag is 68 km.
- (d) Policy guidelines have been issued by the Ministry and standards/manuals have been published by Indian Roads Congress (IRC) to utilize waste plastic and other waste materials such as fly ash, iron and steel slag, construction and demolition (C&D) waste, etc., in construction of National Highways.
