SAVINGS OF AGRICULTURAL GROSS VALUE ADDED PRODUCT

966. DR. RADHA MOHAN DAS AGRAWAL:

Will the Minister of AGRICULTURE & FARMERS WELFARE be pleased to state:

- (a) the average savings of agricultural gross value added product and per agricultural household in various States and Union Territories of the country in terms of percentage of their Gross State Domestic Product (GSDP); and
- (b) whether Government is taking any steps to bridge this wide gap in savings in different States, if so, the details thereof?

(a) to (b): The sector-wise Gross Savings are not centrally maintained. However, as per the National Accounts Statistics- 2022, released by Ministry of Statistics and Programme Implementation (MoSPI), the Gross savings of total economy at Current Prices during the year 2020-21 was Rs. 55,92,446 crore. The State-wise Gross Value Added from Agriculture and Allied Sectors at Current Prices during 2020-21 is at **Annexure**.
