#### MGNREGS IN TELANGANA

#### 755 Shri RavichandraVaddiraju:

Will the Minister of Rural Development be pleased to state:

- (a) whether the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) is being implemented in the State of Telangana;
- (b) if so, the details of the funds sanctioned, allocated and utilized under MGNREGS during each of the last three years and the current year, district-wise;
- (c) whether there are such MGNREGS labourers in Telangana who have not been provided 100 days of employment;
- (d) if so, the details thereof, district-wise; and
- (e) the status of the payment of MGNREGS workers in Telangana?

# ANSWER MINISTER OF STATE FOR RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

- (a): Yes, Sir.
- (b): Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is a demand driven wage employment Scheme. There is no State/UT-wise and district-wise allocation of funds under Mahatma Gandhi NREGS. Funds are not directly released to districts under the Scheme.

Details of funds released to the State of Telangana under Mahatma Gandhi NREGS in the financial year 2020-21, 2021-22, 2022-23 and current financial year 2023-24 and (as on 21.07.2023) are given below:

(c) & (d): Mahatma Gandhi NREGS is a demand driven wage employment Scheme. It provides livelihood security, i.e. fall back options for livelihood for the rural households, when no better employment opportunity is available.

District-wise details of households who completed 100 days of employment in the State of Telangana under Mahatma Gandhi NREGS in the last three financial years 2020-21, 2021-22, 2022-23 and current financial year 2023-24 (as on 22.07.2023) are given at **Annexure.** 

(e): In the financial year 2023-24 (as on 22.07.2023), 99.49 % Fund Transfer Orders (FTOs) are generated within 15 days from the closure of muster rolls in the State of Telangana under Mahatma Gandhi NREGS.
