### **CSR FUND OF NEYVELI LIGNITE CORPORATION**

## QUESTION

## 2120. SHRI C. Ve. SHANMUGAM:

Will the Minister of Corporate Affairs be pleased to state:

(a) the total fund allocated for Corporate Social Responsibility (CSR) by the top ten Central Public Sector Enterprises in the country during the last three years, year-wise and company-wise;

(b) the ranking of Neyveli Lignite Corporation (NLC), among the other CPSEs, vis-à-vis, the fund allocated by NLC towards CSR;

(c) the details of the amount of money allocated/spent out of the total CSR fund of the NLC in Tamil Nadu, especially in the Cuddalore district, which is entirely mines-affected, during the last three years, year-wise and district-wise;

(d) whether NLC has a full-fledged CSR policy with social impacts; and

(e) if so, the details thereof?

(a): There is no provision of allocation of Corporate Social Responsibility (CSR) fund under the Companies Act, 2013. All data related to CSR filed by companies in the MCA21 registry, Development Sector-wise, State-wise and Company-wise is available in public domain at www.csr.gov.in. On the basis of the filings made by the companies in the MCA21 registry, the details of CSR spent by top 10 (CSR expenditure wise) Central Public Sector Undertakings (CPSUs) during last three Financial Years (FY) i.e., 2019-20 to 2021-22 is at Annexure-I.

(b) & (c): There is no such provision. Further, the CSR spent by Neyveli Lignite Corporation (NLC) in the State of Tamil Nadu (including Cuddalore district) for the FY 2019-20 to 2021-22 is at Annexure-II.

(d) & (e): The broad framework of CSR has been provided under Section 135 of the Companies Act, 2013, Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. Under the Act, CSR is a Board driven process and the Board of the company is empowered to plan, decide, execute and monitor CSR activities based on the recommendations of its CSR Committee. The Board of the Company constitutes the CSR Committee and taking into account of the recommendations made by the CSR Committee, approves the CSR Policy for the company. The Board of the company decides the mode of activity/project to be undertaken either by itself or through Implementing Agencies and monitors. The companies are required to disclose the contents of its CSR Policy in its report and place it on the company's website, if any.
