PROMOTION OF ORGANIC FARMING

1793. SHRI C. Ve. SHANMUGAM:

Will the Minister of AGRICULTURE & FARMERS WELFARE be pleased to state:

(a) whether Government is promoting organic farming in the country;

(b) if so, the details thereof including the details of total area covered under organic farming during the last three years, year-wise and State-wise;

(c) details of funds earmarked and spent for promoting organic farming, year-wise and State-wise; and

(d) further steps likely to be taken to promote organic farming in the country?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE

(SHRI NARENDRA SINGH TOMAR)

(a) & (b): Government has been promoting organic farming on priority in the country since 2015-16 through the schemes of Paramparagat Krishi Vikas Yojana (PKVY) and Mission Organic Value Chain Development for North Eastern Region (MOVCDNER). Both the schemes stress on end-to-end support to farmers engaged in organic farming i.e. from production to processing, certification and marketing and post-harvest management Training and Capacity Building are integral part of the scheme. PKVY is being implemented in all the States other-than North Eastern States, across the country whereas MOVCDNER scheme is being implemented exclusively in the NE States.

Under PKVY, assistance of Rs. 50,000 per ha for a period of three years is provided for promotion of organic farming to cover different components like Training & Capacity Building, Data Management, PGS Certification, value addition, marketing and publicity. Out of this, the assistance of Rs. 31,000 per ha for a period of three years is provided to farmers through DBT for on- farm /off – farm organic inputs. Whereas under MOVCDNER, an assistance of Rs. 46,575/ha for 3years is provided for creation of FPO, support to farmers for organic inputs, quality seeds/ planting material and training, hand holding and certification. Out of this, assistance @ Rs. 32500/ ha for 3 years is provided to farmers for off -farm /on –farm organic inputs under the scheme including Rs. 15,000 as

DBT to the farmers and Rs. 17,500 for the planting material to be given to the farmers by State Lead Agency (SLA) in kind.

Year –wise and State wise details of total cumulative area covered under organic farming (under PKVY & MOVCDNER) during last three year is given at **Annexure-I**.

(c): The State wise details of fund allocated and spent/released during last three years for promoting organic farming (under PKVY & MOVCDNER) given at **Annexure-II.**

(d): Organic farming is a priority for the Government and it is envisaged to bring additional 6.00 lakh ha area under PKVY scheme till 2025-26, similarly under MOVCDNER 50,000 ha is targeted to be brought under organic farming till 2025-26.
