## Will the Minister of **PANCHAYATI RAJ** be pleased to state:

- (a) the number of people who received property cards through the scheme, State-wise and year-wise;
- (b) the total number of villages surveyed, State-wise;
- (c) the total expenditure under the scheme, year-wise; and
- (d) whether the Government has reviewed the Parliamentary Committee's recommendation to assign ownership of data corroborated through SVAMITVA to a single Government agency, if so, the details thereof?

## **ANSWER**

- (a) The preparation and distribution of Property Cards on the basis of maps generated under SVAMITVA Scheme by the Survey of India is the responsibility of the respective State Government. As on 6<sup>th</sup> December 2023, 1.63 crores Property Cards have been prepared by the States. The State-wise and Year-wise data on Property Cards prepared by the States is given at **Annexure-I**.
- (b) As on 6<sup>th</sup> December 2023, drone flying has been completed in 2,88,942 villages. The Statewise data is given at **Annexure-II.**
- (c) As on 6<sup>th</sup> December 2023, Rs. 354.52 crores have been released under the SVAMITVA scheme. The year-wise data of funds released is at **Annexure-III**.
- (d) As per the Guidelines/Framework of the SVAMITVA scheme, the State Government shall be responsible for any future updation of rural abadi property data and conducting surveys on

regular basis. The mechanism for future updation of Property data and maps of a State shall be decided by the State Government. The updation of property related data would be done as a part of regular data maintenance of State Revenue Department. It is the responsibility of State Revenue Department officials to update the Property Data.
