- (a) whether Government has any data about milk adulteration or it calls for reports from all State Governments in this regard;
- (b) if so, the specific State-wise updated status of the number of cases of milk adulteration filed in the Country and the punitive action taken thereon during the last three years; and
- (c) if not, the reasons therefor and whether Government will regularly seek such reports along with action taken thereon from all State Governments to protect the health of the common man?

(a) to (c): Food Safety and Standards Authority of India (FSSAI) has conducted PAN-India surveillances for milk and milk products in 2011, 2016, 2018, and 2022. The report of Milk surveillance done by FSSAI in 2018 & 2022 is available in public domain at www.fssai.gov.in/cms/national-surveys.php. Further, FSSAI through State/UTs and its Regional Offices conducts surveillance, monitoring, inspection and random sampling of food products, including Milk & milk products, to check compliance of said standards as per the provisions of Food Safety and Standards Act 2006, Rules and Regulations. FSSAI has also asked the State/UTs to deploy the Food Safety on Wheels for screening/rapid testing of Milk and Milk products.

Based on the information received from the states/UTs, state-wise details of various kinds of food samples (including milk and milk products) analyzed, found non-conforming and action taken during last three years is at Annexure-I, Annexure-II and Annexure-III.
