DEVELOPMENT OF VILLAGES OF PUNJAB NEAR THE BORDER

2036 SHRI SANDEEP KUMAR PATHAK:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the special schemes run by Government for the development of villages of Punjab and other States near the border of Pakistan, if not, the reasons therefor;
- (b) the details of special package given to Punjab for the development of such villages; and
- (c) the funds released each year in the last 5 years by Government to each State/UT for rural development, scheme-wise details thereof?

ANSWER

(a) & (b): The Department of Rural Development (DoRD), Ministry of Rural Development (MoRD) is implementing a number of schemes all over the rural areas of the country, including Punjab and other States near the border of Pakistan, namely Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS), Pradhan Mantri Awaas Yojana–Gramin (PMAY-G), Pradhan Mantri Gram Sadak Yojana (PMGSY), Deendayal Antyodaya Yojana–National Rural Livelihoods Mission (DAY-NRLM), Deen Dayal Upadhyay – Gramin Kaushalya Yojana (DDU-GKY), Rural Self Employment Training Institutes (RSETIs), National Social Assistance Programme (NSAP) and Shyama Prasad Mukherji Rurban Mission (SPMRM). However, SPMRM, which was launched in February, 2016, has been discontinued from 31st March, 2022. Further, Department of Land Resources (DoLR), MoRD is also implementing Watershed Development Component (WDC) of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) which is principally for development of rainfed portions of net cultivated area and culturable wastelands.

However, this Ministry is neither implementing any special scheme for the development of villages of Punjab and other States near the border of Pakistan nor has any special package in this regard. Further, as informed by Ministry of Home Affairs, Department of Border Management, there is not any special scheme for the development of these areas. However, the Border Area Development Programme (BADP), implemented by the Department of Border Management covers all the census villages/town situated within 0-10 Kilometers from the first habitation on international boundary. This is a “gap funding scheme” and its objectives include convergence of all Central/State/Union Territory/Local schemes for the habitations covered under the programme.

(c) : The details of funds released under various schemes of rural development by this Ministry in the last five Financial Years to each State/UT are at **Annexure**.
