HEALTH SECTOR GRANTS TO THE STATES

277. SHRI ELAMARAM KAREEM:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details of the health sector grant recommended to each State by the 15th Finance Commission in the year 2021-22 and 2022-23 respectively;
- (b) whether these grants have already been disbursed to the States, if not, the details of the pending amount to each State in each financial year;
- (c) the details of the reasons for such pendency;
- (d) whether States have requested Government for clearing these dues, the details of the actions taken on these requests; and
- (e) whether it is not a fact that such delay of grants adversely affect the development of health sector, by when these dues will be cleared?

(a) and (b): The Fifteenth Finance Commission (FC-XV) has recommended grants through Local Governments for specific components of health sector to the tune of Rs. 70,051 crores. These grants for health through Local Governments are spread over the five-year period from Financial Year (FY) 2021-22 to FY 2025-26. The State wise details of health sector grants recommended by FC-XV and the amount approved by National Level Committee (NLC) for the year 2021-22 and 2022-23 is

available at Annexure-I. The State wise details of releases as provided by Department of Expenditure (DoE) for the financial year 2021-22 to 2023-24 is at Annexure-II.

(c) to (e): The DoE releases grants on the recommendations of the Ministry of Health & Family Welfare (MoHFW) and the release orders are forwarded to the Ministry. The conditions for release of grant under FC-XV are :

- Submission of Grant Transfer Certificate by States and payment of interest, if any, on delay in transfer of more than 10 days.
- Financial progress as per instructions. [For release of grant of 2022-23, progress of 50% against approval of 2021-22. For release of grant of 2022-23, progress of 75% against approval of 2021-22 and progress of 50% against approval of 2022-23]
