NATIONAL VIRAL HEPATITIS CONTROL PROGRAM

296:DR. SASMIT PATRA:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) the progress of the National Viral Hepatitis Control Program (NVHCP) as of date;
- (b) the number of patients affected by viral hepatitis, especially hepatitis B and hepatitis C, in the country, State-wise; and
- (c) the measures taken by Government to enhance the reach of the program?

(a) The National Viral Hepatitis Control Program (NVHCP) was rolled out in 2018 under the aegis of National Health Mission in line with Sustainable Development Goal (SDG) 3.3. The program envisages prevention through awareness generation and management of viral hepatitis by provisioning free diagnosis and treatment. During July 2018 to September 2023, around 8.13 crore individuals were benefitted by the program and more than 2.74 lakh patients received treatment of viral hepatitis. Around 4800 Master Trainers have been created across the country to cascade training in diagnosis, treatment and monitoring for scaling up program implementation.

(b) The details of number of patients affected by Hepatitis B and Hepatitis C are **annexed**.

(c) Currently services for the diagnosis and treatment of viral hepatitis are available in all the States and UTs. The program has collaborated with existing programs such as the National Program for Surveillance of Viral Hepatitis (NPSVH), Reproductive, Maternal, Newborn, Child, Adolescent Health and Nutrition (RMNCHA+N), Universal Immunization Program, National AIDS Control Program etc. for effective implementation of the program. The program has paperless data recording and reporting on NVHCP Management Information System for robust monitoring and evaluation. Till date, 978 treatment sites have been established across the country where preventive and treatment services are provided to the beneficiaries.
