NATIONAL HEALTH MISSION IN TAMIL NADU

297 Dr. KANIMOZHI NVN SOMU:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details of health programmes run by Government under National Health Mission (NHM), State/UT-wise;
- (b) whether the salary of contractual employees working in various States/UTs under the said Mission is increased by Government every year;
- (c) if so, the details of the increased salary post-wise and employees of various categories in Tamil Nadu during the last five years; and
- (d) the details of funds allocated and released in health sector, State/UT-wise including Tamil Nadu?

(a): The various health programmes implemented by the Government of India under NHM includes operationalisation of Ayushman Arogya Mandir erstwhile Ayushman Bharat-Health and Wellness Centres (AB-HWCs) by transforming the existing Sub Centres and Primary Health Centre, support for engaging of health human resource on contractual basis, National Ambulance Services, Mobile Medical Units, ASHAs, Infrastructure strengthening, 24 x 7 Services and First Referral facilities, Mera Aspataal, Kayakalp Award Scheme, Prime Minister's National Dialysis Programme, National Quality Assurance Standards implementation and related Activities, LaQshya Certification, Biomedical Equipment Maintenance and Management Programme, Free Diagnostics Service Initiative and Free Drugs Service Initiative. Further, initiatives such as Mission Parivar Vikas, Adolescent Friendly Health Clinics (AFHCs), Weekly Iron Folic Acid Supplementation (WIFS), Menstrual Hygiene Scheme, Facility Based Newborn Care (FBNC), Home Based Newborn Care Program, Social Awareness and Actions to Neutralize Pneumonia Successfully (SAANS), Home Based Care for Young Child (HBYC), Rashtriya Bal Swasthya Karyakram (RBSK), Rashtriya Kishor Swasthya Karyakram (RKSK), Early Childhood Development (ECD), Comprehensive Abortion Care (CAC), Anemia Muk

Bharat (AMB) strategy, Pradhan Mantri TB Mukta Bharat Abhiyaan (PMTBMBA), Nutrition Rehabilitation Centre (NRC) program and Universal Immunization programme.

(b) & (c): The Ministry of Health and Family Welfare provides technical and financial support to the States/UTs to strengthen the public healthcare system, based on the proposals received in the form of Programme Implementation Plans (PIPs) under National Health Mission. Government of India provides approval for the proposals in the form of Record of Proceedings (RoPs) as per norms & available resources. Based on the proposals from State/UTs, MoHFW approves till maximum 5% annual increment and 3% for rationalization of the total HRH budget. The approval under NHM for last 5 years to Tamil Nadu is as follows:
