**WOOLEN AND SILK KHADI FABRIC WOVEN IN THE COUNTRY**

116. SHRI ANEEL PRASAD HEGDE:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the quantum of woolen and silk khadi fabric woven, State-wise and year-wise since 2018, item-wise; and
- (b) the number of metres of yarn of woolen and silk Khadi fabric produced, State-wise and year-wise since 2018, item-wise?

(a): Details of the quantum of woolen and silk khadi fabric woven, State-wise and year-wise since 2018-19 to 2022-23, item-wise is placed at Annexure.

(b): Yarn is produced in the form of hank and hence, the number of metres of yarn of woolen and silk Khadi fabric produced cannot be furnished. State-wise data of woollen and silk Khadi yarn produced is not available. However, Year-wise value of woollen and silk Khadi yarn produced since 2018-19 to 2022-23 is as follows:
