Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the number of applications received under Prime Minister's Employment Generation Programme (PMEGP) from banks, year-wise since 2017-18;
- (b) the amount of margin money and credit-linked money released year-wise and State-wise including Odisha since 2017-18;
- (c) whether Government has carried out a study to analyze the impact of Covid-19 on employment generation; and
- (d) if so, the details thereof and if not, the reasons therefor?

(a): The number of applications for Margin Money (MM) claims received from banks under Prime Minister's Employment Generation Programme (PMEGP) since 2017-18 and till 2023-24 (as on 22.11.2023) is given below:

(c) & (d): Yes, Sir. Ministry of MSME, through Khadi & Village Industries Commission (KVIC), has carried out a third-party Evaluation Study which was conducted by Indian Institute of Public Administration (IIPA) in April 2023 to assess the impact of COVID-19 on KVI sector institute/ PMEGP units. It covered sample of 11,126 PMEGP units across 30 States/UTs during field survey. The study focused on the production, sales and employment generated by the units / institutions under the Khadi & Village Industry program in the country. The study, inter-alia, finds that the average number of male employees in PMEGP units was increased by 20% in FY 2021-22 (post Covid) in comparison to number of female employees, where it was decreased by 25%. The study also finds that the number of employees (male and female) was changed marginally from FY 2017-18 to FY 2021-22.
