160. SHRI MALLIKARJUN KHARGE:

Will the Minister of STEEL be pleased to state:

- (a) the details of the total number of steel plants in the country in the last five years, State-wise and year-wise;
- (b) the details of the total capacity of steel plants in the country in the last five years, State-wise and year-wise;
- (c) the number and details of steel plants disinvested in the last five years, State-wise and year-wise;
- (d) the number and details of steel plants privatised in the last five years, State-wise and year-wise; and
- (e) the reasons for such disinvestment/privatisation, plant-wise?

(a)&(b): The details of the total number of steel plants in the country in the last five years along with capacity is given in **Annexure I**.

(e) The Government follows a policy of disinvestment through the Strategic disinvestment and Minority Stake Sale. Strategic Disinvestment/sale implies the entire or substantial sale of Government shareholding of PSEs, along with the transfer of management control.
