STATUS OF POSHAN ABHIYAN SCHEME

477: SHRI SUJEET KUMAR:

Will the Minister of Women and Child Development be pleased to state:

- (a) whether Government is aware that the data from the POSHAN Trackers doesn't exist in the public domain;
- (b) if so, remedial measures taken by Government for the same;
- (c) the amount of funds approved and released under Poshan Abhiyan during the last five years, State-wise;
- (d) whether Government has carried out the analysis of implementation of the said scheme during the last five years;
- (e) if so, the details thereof; and
- (f) if not, the reasons therefor?

ANSWER

(a) to (b) The data from the Poshan tracker application is available in the public domain since March 2021 onwards. IT systems have been leveraged to strengthen and bring about transparency in nutrition delivery support systems at the Anganwadi centres.

The Poshan Tracker application facilitates monitoring and tracking of all AWCs, AWWs and beneficiaries on defined indicators. Technology under Poshan Tracker is being leveraged for dynamic identification of malnutrition prevalence among children. The mobile application has also facilitated digitization and automation of physical registers used by AWWs that helps in improving their quality of work.

(c) The State/UT wise details of funds released under POSHAN Abhiyaan during the last five years is at **Annexure I**.

(d) to (e) Development Monitoring & Evaluation Office (DMEO) under NITI Aayog has conducted Sectoral Evaluation of schemes including POSHAN Abhiyaan, wherein, performance of the Scheme was found 'Satisfactory' in the criteria of Relevance, Sustainability and Equity. Further, NITI Aayog assessed the implementation of POSHAN Abhiyaan since its inception and came out with the following key findings:

- i. POSHAN Abhiyaan has helped to bring a strong focus on improving nutrition outcomes during the first 1,000 days.

- ii. POSHAN Abhiyaan has enabled a nation-wide jan-andolan catalysing nutrition related behaviour change at scale for positive impact on feeding and health care practices.
 - iii. It has demonstrated that the processes for inter-sectoral convergence are effectively operationalized through in place institutional mechanisms at multiple levels.
 - iv. POSHAN Abhiyaan showed that technology can be leveraged for real time monitoring of large scale health and nutrition programmes.
 - v. It has supported the resilience of health and nutrition systems during covid-19 pandemic.
