By integrating modern farming techniques and providing training to farmers, the Corporation can enhance agricultural productivity while mitigating the environmental impact of traditional practices. In essence, the establishment of a Fodder corporation of India is not just a necessity but a strategic imperative for fostering sustainable agriculture, preserving the environment, and safeguarding the well-being of future generations. It represents a forward-thinking approach to balance agricultural needs with environmental conservation, ensuring a harmonious coexistence between farming practices and ecological integrity.

I urge the Government to establish Fodder Corporation of India.
