- (b) the details of specific projects or initiatives to be planned in Gujarat to enhance railway connectivity and contribute to the overall development of the region; and
- (c) whether the Ministry could outline the timeline and milestones for major railway development projects in Gujarat mentioned in the budget?

**STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF UNSTARRED QUESTION NO. 914 BY SHRI ZALA KESRIDEVSINHJI ANSWERED IN RAJYA SABHA ON 09.02.2024 REGARDING DEVELOPMENT OF RAILWAY INFRASTRUCTURE IN GUJARAT**

(a) to (c): The Railway projects are sanctioned/executed Zonal Railway-wise and not State-wise/Region-wise as the Railways' projects may span across State boundaries. However, as on 01.04.2023, total 36 Railway Infrastructure Projects (6 New Line, 18 Gauge Conversion and 12 Doubling), of total length of 3,200 km, costing ₹30,789 crore falling fully/partly in the State of Gujarat are in planning/ approval/ construction stages, out of which 735 km length has been commissioned and an expenditure of ₹6,113 crore has been incurred upto March, 2023. These include:

- (i) 6 New Line projects of total length of 520 km costing ₹6,950 crore, out of which 90 km length has been commissioned and an expenditure of ₹2,227 crore has been incurred upto March, 2023.
- (ii) 18 Gauge Conversion projects of total length of 1,567 km costing ₹12,336 crore, out of which 645 km length has been commissioned and an expenditure of ₹3,527 crore has been incurred upto March, 2023.
- (iii) 12 Doubling projects of total length of 1,113 km costing ₹11,502 crore, out of which an expenditure of ₹360 crore has been incurred upto March, 2023.

New Line, Gauge Conversion and Doubling projects falling fully/partly in the State of Gujarat are covered by Western Railway and North Western Railway Zones of Indian Railways. Zone-wise details of all Railway Projects including cost, expenditure and outlay are made available in public domain on Indian Railways website.

Since 2014, there has been substantial increase in fund allocation and commensurate commissioning of projects across Indian Railways. Budget allocation for infrastructure projects and safety works falling fully/partly in the State of Gujarat is as under:

Commissioning of infrastructure projects falling fully/partly in the State of Gujarat is as under:

Completion of Railway project/s depends on various factors like land acquisition by State Government, forest clearance by officials of forest department, shifting of infringing utilities, statutory clearances from various authorities, geological and topographical conditions of area, law and order situation in the area of project/s site, number of working months in a year for particular project site due to climatic conditions etc. All these factors affect the completion time of the project/s.
