FLIGHTS GROUNDED DUE TO ENGINE TROUBLES

Will the Minister of CIVIL AVIATION be pleased to state:-

- (a) the number of fleet-type wise from amongst Indian carriers grounded due to engine and or other issues, if so, the details thereof;**
- (b) the number of planes grounded due to engine supply chain issues;**
- (c) the number of planes grounded due to Go First insolvency resolution;**
- (d) the number of planes grounded due to financial mismanagement of the concerned airlines or funding issues;**
- (e) the number of aircrafts of Indian airlines seized by lessors or creditors abroad; and**
- (f) airline-wise break up of owned aircraft and under sale and lease back?**

ANSWER

Minister of State in the Ministry of CIVIL AVIATION (GEN. (DR) V. K. SINGH (RETD))

(a) There are total 157 aircraft grounded due to engine or other issues, the details is attached at Annexure-A.

(b) There are total 101 out of 157 aircraft grounded due to engine supply chain issues, the details airline wise is as follow.

(c) & (d) A total of 54 aircraft are grounded due to Go First insolvency process.

(e) There are no Indian Carrier's aircraft seized by lessors or creditors abroad.
